Notice is hereby given that the Board of Directors of Springwoods Municipal Utility District will hold a regular meeting on **Tuesday, March 13, 2007, at 6:00 p.m.** at 9117 Anderson Mill Road, Austin, Texas, for the following purposes:

3. Receive a report from the District's drainage channel, park maintenance and composting contractor and discuss and consider taking necessary action related thereto;
4. Receive a report from the District's general manager and discuss and consider taking necessary action related thereto, including:
 - (a) Approving the payment of bills and invoices received by the District;
 - (b) Annual Consumer Price Index adjustment;
 - (c) Proposal for removing pump house in park; and
 - (d) Budget amendment, including Resolution Adopting Amended Budget;
5. Receive a report from the District's attorney and discuss and consider taking necessary action related thereto, including legal action regarding restrictive covenant enforcement;
6. Receive a report from the District's security patrol contractor;
7. Receive a report from the District's solid waste disposal contractor;

8. Discuss and consider taking necessary action regarding Resolution Adopting Amended and Restated Rules Relating to Enforcement of Restrictive Covenants;
9. Discuss and consider taking necessary action regarding Resolution Authorizing Payment of Fees of Office;

10. Discuss and consider taking necessary action regarding inventory services update being prepared by Klar Communication, including video update;
11. Discuss and consider taking necessary action regarding tree trimming work by Davey Tree Expert Company;
12. Discuss and consider taking necessary action regarding maintenance, repairs and improvements to the District pool facilities and other related matters, including pool use by Stingrays Swim Team;

Discuss and consider taking necessary action regarding design and construction of (i) the regional storm water drainage facilities and related improvements and (ii) the miscellaneous drainage channel improvements contemplated under the Fourth Supplement to Revised Agreement Concerning Springwoods Municipal Utility District;
14. Discuss and consider taking necessary action regarding maintenance, repairs and improvements to the District park;

If the Board of Directors determines to go into executive session on any item on this agenda, the Presiding Officer will announce that an executive session will be held and will identify the item to be discussed and provision of the Open Meetings Act that authorizes the closed or executive session.
