5. Receive a report from the District's general manager and discuss and consider taking necessary action related thereto, including approving the payment of bills and invoices received by the District;

8. Discuss and consider taking necessary action regarding approval of extension of the term of the Management Services Agreement with Eco Resources, Inc.;

10. Discuss and consider taking necessary action regarding maintenance, repairs and improvements to the District pool facilities and other related matters, including pool use by Stingrays Swim Team;

Discuss and consider taking necessary action regarding design and construction of (i) the regional storm water drainage facilities and related improvements and (ii) the miscellaneous drainage channel improvements contemplated under the Fourth Supplement to Revised Agreement Concerning Springwoods Municipal Utility District;

If the Board of Directors determines to go into executive session on any item on this agenda, the Presiding Officer will announce that an executive session will be held and will identify the item to be discussed and provision of the Open Meetings Act that authorizes the closed or executive session.
