Notice is hereby given that the Board of Directors of Springwoods Municipal Utility District will hold a regular meeting on **Tuesday, October 9, 2007, at 6:00 p.m.** at 9117 Anderson Mill Road, Austin, Texas, for the following purposes:

GENERAL

1. Receive citizens' communications and consider taking any necessary action related thereto;

2. Approve meeting minutes of the September 11, 2007 meeting;
3. Resolution Confirming Annual Review of District's Code of Ethics and Financial Investment, Travel and Professional Services Policy and Investment Strategy;

These purposes include receiving legal advice from its attorney (Section 551.071); discussing real property matters (Section 551.072); discussing gifts and donations (Section 551.073), discussing personnel matters (Section 551.074) or discussing security personnel or devices (Section 551.076). If the Board of Directors determines to go into executive session on any item on this agenda, the Presiding Officer will announce that an executive session will be held and will identify the item to be discussed and provision of the Open Meetings Act that authorizes the closed or executive session.
